Technical Skills:

Did the reader offer you pieces of evidence (evidential mediumship) and/or elements of the energy of an energy or a guide, as part of the initial, connection phase of their process?

Did they pause to gain agreement to move forward?

Did the reader vet and share with you further info on the energy connected to, whether a dead person or a spirit guide or the energy of someone living?

Additionally, if it was a spirit guide did they offer you what dimension that the guide or energy was from?

Did the reader offer messages after making the connection, vetting the energy and providing either energy signature elements or pieces of 'evidence'?

Did you/the receiver offer confirmation as well as you/they could throughout the process?

Was 'past-life' information offered?

Was your aura or were your chakras addressed?

Did the reader get your verbal permission for any energy clearing during the session?

How would you describe the Reader's style? Warm, confident, open, knowledgeable, compassionate, etc.

Did the reader address legal, financial or health situations? Did they offer you a disclaimer regarding these topics?

Did you feel confused in your session at all? If so, was the Reader able to dispel it?

Please offer two compliments on the reader's process and one piece of constructive criticism for their process.
